Course Description

This course provides academic credit for independent studies under the direction of a faculty member. The scope and direction of the studies are determined by the student (or small group of students) in consultation with the course instructor.

Course Learning Outcomes

By enrolling in this course, students will:

1. Gain experience in performing independent studies on topics that are not taught in a formalized course setting.

Required Course Materials

No textbooks or materials are required. Resources for research are determined in consultation with the instructor. If a textbook or other material that carries an ISBN is assigned later in the term, it will be identified by full citation (including ISBN for books).

Grading Policy

Specified on the course form along with deliverables for the independent study. This course is graded on a standard letter scale (A – F).

- A grade of **A** indicates that the student has made acceptable progress in their research toward degree completion, consistent with the number of thesis credit hours for which the student is enrolled for the semester.
- A grade of **B** indicates that the student has made some progress in their research toward degree completion, consistent with the number of thesis credit hours for which the student is enrolled for the semester, yet with some deficiencies such as not meeting expectations regarding deliverables.

- A grade of **C** indicates that the student has made some progress in their research toward degree completion, consistent with the number of thesis credit hours for which the student is enrolled for the semester, yet with substantial issues such as missing deliverables, deadlines, etc.
- A grade of **D** or below indicates that the student did not meet the expectations for satisfactory performance during the term.

Weighting: Final grades reflect holistic evaluation using the categories above and expectations documented on the course form and/or in writing between the instructor and student, rather than fixed percentage weights typical of a multi-component lecture course.

Attendance Policy

This course does not include scheduled class meetings. The frequency and format of student–faculty contact are determined by mutual agreement and are consistent with the number of credit hours for which the student is enrolled.

Additional Criteria for Successful Completion

Successful completion requires meeting objectives and expectations agreed with the instructor, maintaining contact and engagement appropriate to the registered credit hours, completing any documented deliverables or milestones, and complying with all applicable Georgia Tech academic and conduct policies.
