Course Description

All MID students will develop an independent masters-level thesis or project. The thesis/project will engage problems in design which may be theoretical, applied, or innovative in nature. All master students demonstrate through the thesis/project the ability to define a design challenge or research question which is framed within an existing body of knowledge, conduct design research to objectively investigate the challenge/question, develop and implement methods to objectively investigate the question, demonstrate the ability to apply results of investigations to design practice, and communicate the results in written and verbal form.

Course Learning Outcomes

Upon completion of the course students are expected to demonstrate knowledge, skill and abilities in the following areas:

- Define a design problem or challenge related to a chosen topic of interest that can be investigated
- Demonstrate understanding of previous work and the current state of the art in the chosen area
- Demonstrate ability to develop and implement valid methods to investigate the problem/challenge
- Demonstrate the ability to analyze and interpret data from the investigation and draw valid conclusions
- Persuasively present conclusions and impacts from the results orally and in writing
